

The terms and conditions for availing medical facilities are as under:-

1. The medical facility/treatment under this shall be available only to “employees and their dependents” of Central University of Gujarat.
2. The employee will have to take reference letter from the University’s Consultant Doctor- Dr. Bhupendra B. Shah (Faculty Block, Sector 30, Central University of Gujarat, Gandhinagar, Mob. 9427022077) or Dr. Anjana Ved (Faculty Block, Sector 30, Central University of Gujarat, Gandhinagar, Mob. 9429459829). Employees need to carry their ID card of the University along with them.
3. The reference letter will have to be produced to the consultant doctor.
4. The consultation will be at CGHS rates which will be directly paid by the University.

For **HOMEOPATHY- Authorized Medical Officer**

1. Employees will have to take the reference letter for first consultancy with the homeopathic doctor. Consecutively they can directly go to the doctor and take medication. Employees need to carry their ID card of the University along with them.
